1. 2022 Annual Meeting Minutes

On the motion of Kripa Khatri, seconded by Nigel Dalton-Brown, the minutes of the 2021 Annual Meeting were accepted.

2. Chairperson's Annual Report for period ending 28 July 2022

- There were 7 Chapter Council meetings held in the past 12 months, this excludes the Annual Meeting held on 28 July 2021.
- With ongoing restrictions arising from the pandemic, keeping in mind safety and working from home culture, all meetings were held virtually.
- As at today, there are 12 full members on the Chapter Council.
- The Council has great representation from diverse backgrounds, experience, skill sets, industries, focus areas including government, consulting, and professional services.
- The Chapter is well represented within the IIA. Stephen Tiley (Chair and President of the IIA-Australia) is based in Victoria, as is Director Judith Charlton. Tania Stegemann and Sally-Anne Pitt are members of the IIA Global Board.
- As at today, there are 548 members of IIA Australia that are associated with the Victoria Chapter that represents 18% of the total membership of IIA Australia.
- The current retention rate for the past 12 months for IIA Australia Victoria Chapter about 88.2%.
- In the last 12 months, 15 new members joined the Victoria Chapter.
- All other member meetings in the past 12 months have been held to serve the members nationally to leverage work done across all the Chapters in IIA.
- The Chapter has organized 3 meetings in the last 12 months Nationally including the celebration of the 60th Anniversary Event and the joint RMIA event with the NSW Chapter.
- In the 2nd half of the year several events are planned:
 - Casual Coffee Catch ups planned across various parts of Victoria including regional locations.
 - Book Club Discussions
 - Mentoring Program will be rolled out soon



 Discussions and planning for other events focusing on Young Members, Audit Executive Network and Christmas catch up are underway.

Challenges and opportunities:

- The first six months of the past financial year were challenging for the Victoria Chapter with loss of key Council Members due to the pandemic and health reasons. On the flip side it opened up positions for other members to join which resulted in inducting and onboarding six new Council Members in March 2022.
- The other key challenge has been with face-to-face meetings, with easing restrictions
 and increasing activity in the CBD and surrounds we are looking at new and innovative
 ways to increase in-person contact and networking which has not been possible for the
 past couple of years.

3 Election of the 2022/2023 Chairperson and Vice-Chair

- Nigel Dalton-Brown was elected as the Victorian Chapter Chair for 2022/2023 via a majority vote (93% For, 7% Abstentions).
- Aamir Husain was elected as the Victorian Chapter Vice Chair for 2022/2023 via a majority vote (86% For, 4% Against, 11% Abstentions).
