

The Bob McDonald Award

The Bob McDonald Award is named in honour of the first Australian to hold the position of International Chairman of IIA Inc and of his outstanding contribution to the profession of internal audit.

The Award is made to an individual in recognition of outstanding service to the internal audit profession in Australia, to the Institute of Internal Auditors - Australia, or to the theory of internal audit or to the practice of internal audit.

Nominees must be financial members (Professional Member or Associate Member) of the IIA-Australia.

Confidentiality in nomination is essential and nominees should not be aware that they are being nominated for an award. Premature disclosure of details may prejudice consideration of the nomination.

Nominations are considered by the national awards panel which makes recommendation to the Board of Directors. More than one award may be made each year if there are multiple nominations which are considered worthy of the award. Details are published only when a nomination is successful.

Please note that current IIA-Australia Board members are not eligible to be considered.

The nomination form will be available on the website or on request from the Executive Officer & Company Secretary, IIA-Australia.

Nominations can be submitted at any time although there is a formal call for nominations once a year. Award/s are usually presented at the following SOPAC® or can be presented at some other IIA-Australia event.

The award was approved by the IIA-Australia National Board in February 2004.
